Policy Equipment Subsidy

- All subsidies to be approved by Club Management Committee prior to equipment purchase.
- All requests for subsidies to be submitted by 31st. July each year and must be submitted on the approved application form
- Club Management Committee will consider each request and a decision advised to applicant by 31st. August
- The level of subsidies to be limited to \$3000 per financial year.
- Unused subsidy allocation does not accumulate to following financial year
- The subsidy is only available to financial Full Active patrolling members of Shellharbour SLSC Inc. holding as a minimum SLSA Surf Bronze Medallion qualification.
- Subsidy scheme program will be subject to availability of club funds.
- Subsidy limited to 30 percent or lower rate of full purchase price at discretion of the committee pending number of applications per financial year.
- Subsidy limited to SLSA approved new single racing skis and new Malibu racing boards.
- Subsidy will only be released on presentation of formal Tax Invoice\Receipt from supplier and will be paid direct to manufacturer or subsidy applicant as applicable.
- At the beginning of the patrol season a review of subsidy recipient's compliance with conditions will be conducted. Non compliance of conditions, by subsidy recipient, will lead to forfeiture of subsidy
- Limit of 1 subsidy/equipment purchase per member per financial year.
- Craft to be kept for minimum of 2 years, unless unable to pass SLSA scrutineering, or subsidy may be forfeited.
- Club has first option to purchase subsidised equipment, at a fair market price, when sold by member
- Management Committee & subsidy recipient (&\or guardian) will formally enter into an agreement acknowledging subsidy terms and conditions.
- The member must complete his\her minimum surf patrol obligations, failure to do so will result in the Club requesting immediate forfeiture of the subsidy.
- The member would be expected to participate in regular surf club competition and activities. Including club, branch, state and national level competition and fund raising activities as his\her own work, education and family commitments permit.
- Conflicts of sponsorship interests to be avoided wherever possible and the Management Committee reserves to reject any subsidy request that is considered contrary to SLSA ideals.
